Fidelity Funds updated fees and costs disclosure (ASIC Regulatory Guide 97)

26 February 2021

In accordance with our obligations under **ASIC's Regulatory Guide 97: Disclosing fees and costs on PDSs and periodic statements** (RG 97), FIL Responsible Entity (Australia) Limited (ABN 33 148 059 009 AFSL No. 409340) (FREAL) has undertaken a half yearly review of the fees and costs disclosed in the Product Disclosure Statements (PDSs) for the Fidelity Funds (as listed in Annexure A) for which FREAL is Responsible Entity.

FREAL wishes to advise of the following updated fees and costs disclosed under RG 97 for the relevant Fidelity Funds which are current for the 12 month period ended 31 December 2020. As the updated fees and costs are not materially adverse, FREAL is updating this information via our website (<http://www.fidelity.com.au/>) and the ASX mFund Settlement Service in accordance with **ASIC Instrument 2016/1055**. This notice is also to provide existing investors with information about the costs incurred in relation to the Funds.

Section 6 of each PDS for the relevant Fidelity Fund is amended by replacing all references to the relevant Management costs, Total Transactional costs, Buy-sell Spread, Buy-sell Spread Recovery, Reduction of returns to the Fund, and Total Management and Transactional costs in each PDS with the relevant information set out in Table 1.

* These costs are expressed as a percentage of the Fund's average net asset value and are estimated based on the 12 month period ended 31 December 2020.

** The investment mandate for the Fidelity FIRST Global Fund was changed effective from 1 June 2020 and the Fund was re-named the Fidelity Sustainable Water & Waste Fund. The estimated figures in this row are based on a combination of the actual transactional and operational costs incurred by the Fidelity FIRST Global Fund from 1 July 2019 to 31 May 2020 and the Fidelity Sustainable Water & Waste Fund from 1 June 2020 - 30 June 2020. Because of the investment mandate change, FREAL considers that the total transactional costs incurred by the Fund for the period ended 30 June 2020 may not be a good indication of the transactional costs to be borne in the next financial year for the Fidelity Sustainable Water & Waste Fund.

*** Fidelity Global Future Leaders Fund was launched on 28 September 2020, the costs are estimated and projected as 12 month period ended 31 December 2020. No Performance fee was charged during the period.
