## Target Market Summary - **Fidelity Hedged Global Equities Fund**

This product is likely to be appropriate for a consumer seeking **capital growth**, to be used as a **core or small component** of their portfolio where the consumer has a minimum investment timeframe of **7 years** and a **very high** risk/return profile.

### Instructions

### Investment products and diversification
